Thank you for your interest in the 2025 Boyle PEA VINE FESTIVAL Friday April 11th 2025 and Saturday April 12th 2025. Please read the following rules and guidelines prior to submitting your vendor application. By submitting your application, you agree to the rules below and acknowledging that you understand the guidelines. Your application will be submitted to the committee for approval.

- In order to participate in Boyle Backyard Tailgating FEST, Foods, Beverages, Desserts, etc. may be served.
- The \$100 vendor fee includes both days of the event (Friday, April 11th and Saturday, April 12th). No discounts will be given for single-day participation.
- Upon approval, Inflatable/Ride vendors will be required to submit a copy of general liability insurance with a limit of not less than \$1,000,000 per occurrence.
- Vendor applications will not be accepted after the submission deadline of Tuesday, April 1st, 2025.
- Submitting a vendor application does not guarantee participation. All applications will be reviewed, and applicants will be contacted following the submission deadline regarding the status of their approval.
- Space is limited. Event organizers reserve the right to accept or deny any applicant based on availability, menu offerings, space constraints, etc.

Application submitted after this date will not be considered. There are a limited number of vendor spaces available for the event. Submission of an application does not guarantee participation. Vendors will be contacted via email regarding the status of their application once application has been reviewed. The committee reserves the right to accept or deny any vendor application. The committee reserves the right to place vendors wherever deemed appropriate. Vendors are responsible for providing everything required for their set-up. Vendors are required to leave their space clean at the end of the event and in the same condition in which they received it. At the time of application. Upon approval vendors will be required to provide a copy of general liability insurance with a limit of not less than \$1,000,000 per occurrence. Failure to submit required documentation and/or payment will result in removal from the event. **NOTE: VENDORS RETAIN ALL THEIR PROFIT**

RELEASE, INDEMNITY, AND WAIVER OF LIABILITY (VENDOR TO SIGN)

I, the Vendor, do hereby knowingly, freely, and voluntarily assume all liability for any damage or injury that may occur as a result of the Vendor's participation in event(s) to be held at The PeaVine Festival Events in Boyle, Mississippi, and agree to release, waive, discharge, and covenant not to sue The PeaVine Festival and/or The Town of Boyle (Mississippi), its current and former officers, agents, employees, and volunteers (collectively, the "Releasees") from any liability or claims for damage or injury that may be sustained by the Vendor, its officers, employees, or agents, or any third party directly or indirectly in conjunction with, or arising out of, the Vendor's participation in the event(s).
